Student Opportunity Act (Chapter 132 of the Acts of 2019)

- ❖ Lawrence will receive \$21,784,737 in Student Opportunity Act funds next year.
- ❖ Districts are required to submit a three-year, evidence-based plan aimed at closing persistent disparities in achievement among **student subgroups**.
 - ➤ District plans should be a commitment to do a few things well; it should not be a comprehensive strategic plan
 - > The Student Opportunity Plan is due April 1,2020
 - > We need feedback and ideas from the Lawrence community!

Four Commitments of the SOA

- **1.Intentionally focus on student subgroups** who are not achieving at the same high levels as their peers;
- 2.Adopt, deepen or continue specific evidence-based programs to close opportunity and achievement gaps for student subgroups and allocate resources to support these programs;
- 3.Monitor success in reducing disparities in achievement among student subgroups over three years with a small number of metrics and targets; and
- **4. Engage families, particularly those families representing student subgroups** most in need of support, about how best to meet their students' needs.

Recent LPS Student Subgroup Data

The number of Students with Disabilities, English Learners, and High Needs Students rose in 2018-19.

| Subgroup | 2017-18 | 2018-19 |
|----------------------------------|---------|---------|
| Students with Disabilities (SWD) | 16.7% | 19.2% |
| English Learners | 34% | 35.9% |
| High Needs | 82.9% | 84.4% |

Recent LPS Student Subgroup Achievement

| Subgroup | 2018 - %of students meeting/exceeding expectations on ELA MCAS | 2019 - %of students meeting/exceeding expectations on ELA MCAS |

| All Students | 28% | 30% |
| Students with Disabilities (SWD) | 5% | 6% |
| EL and Former EL | 20% | 22% |
| High Needs Students | 25% | 27% |

 - **1. Lawrence Possibilities** (The district leadership team identified some possible initiatives aligned to the priorities and evidenced-based programs)
